Munich is the capital of Bavaria and one of Germany's most vibrant and historic cities. Known for its elegant architecture, green parks, and lively beer gardens, it attracts millions of visitors every year. The city beautifully combines tradition and innovation:

- centuries-old landmarks such as Marienplatz, Frauenkirche, and Nymphenburg Palace
- modern museums, research centers, and technology companies.

Munich is also world-famous for Oktoberfest, the largest beer festival in the world, which celebrates Bavarian culture through music, food, and local costumes. Information on the processing of personal data

for the purpose of preparing and organising the FICEP Youth Congress. This includes, for example, the administration of registration, the organisation of catering and meeting rooms for the participants, the creation of participant lists, accreditation, the creation and publication of photos, videos and reports, as well as press and public relations work.

The legal basis for these processing activities is contract fulfilment pursuant to Art. 6 para. 1 lit. b GDPR, legal obligation pursuant to Art. 6 para. 1 lit. c GDPR (e.g. BAO, state laws on tax law) and legitimate interest pursuant to Art. 6 para. 1 lit. f GDPR. The legitimate interest lies in the fulfilment of the respective statutory tasks and purposes of SPORTUNION.

The registration for the FICEP Youth Congress is carried out via SPORTUNION, which announce/register the participants. The data may be transmitted to IT service providers, media companies and media services for the purposes described. For the organisation and booking of accommodation for the participating persons, the data will be transmitted to the accommodation operators. The data provided will be stored until cancelled. Project results are stored and published on the basis of the legitimate interests of SPORTUNION Austria for archiving purposes - also in accordance with Art 17 para 3 in conjunction with Art 89 GDPR. There is no right to cancellation of this data.

Data will not be transferred to a third country or an international organisation, except to the FICEP to proceed with the Congress registration and fulfill all obligations for the funding. There is no intention to process the data for automated decision-making including profiling (data analysis of behaviour, habits, preferences, ...). Participants have the right of access, rectification, erasure (except for processing for archiving purposes in the legitimate interest), data portability, restriction of processing and objection, as well as the right to lodge a complaint with the Austrian Data Protection Authority, Wickenburggasse 8, 1080 Vienna, at any time.

The disclosure of the data is a prerequisite for participation as volunteer at the FICEP Youth Congress. Participation at the FICEP Youth Congress is not possible without providing the data.

At the events, SPORTUNION will also take photos for the purpose of reporting and presenting the activities via its own and third-party media (including social media) and publish them accordingly. The legal basis for this is legitimate interest in accordance with Art. 6 para. 1 lit f GDPR and §§ 12 and 13 DSG. The legitimate interests lie in public relations work, the presentation of the activities of those responsible and in enabling the organisation of the event by promoting it.

The data will be forwarded to processors who work on behalf of the SPORTUNION for production, layout and publication. They are made available to the public on the internet or published on social media channels. In the context of publication in social media channels, it is possible that the respective service will receive utilisation rights to the published data.

The data will be stored for a period of 7 years and then deleted - deletion from the website or social media channels will take place as far as technically possible. Deletion from print media that have already been published is not possible. The above applies with regard to the rights of data subjects. There is no obligation to provide the data (to make oneself available for photographs), an objection can be lodged against processing in the legitimate interest, unless there are compelling legitimate grounds for processing by SPORTUNION that outweigh the rights and freedoms of the data subject (balancing of interests).

SPORTUNION points out that it can be assumed that the reporting on the event supported by photos is within the reasonable expectations of the data subject and that care is taken to ensure that the rights and freedoms of the data subject are not violated during the recording and publication process.
